

Cardiff Arms Park Ground Regulations.

Below are the Ground Regulations when attending events at Cardiff Arms Park.

- (1) The right of admission to Cardiff Arms Park, CF10 1JA (hereinafter called the Ground) is reserved to Cardiff Blues Ltd trading as Cardiff Rugby (hereinafter called the Company). The term Ground means all external areas, structures and buildings within the boundary of the ground.
- (2) All persons entering the Ground are admitted subject to the Ground Regulations and related Policies as stated. Entry to the Ground shall be deemed to constitute unqualified acceptance of these Regulations. Notices displaying the Ground Regulations are displayed at each entrance and a copy is on the Cardiff Rugby website.
- (3) All persons entering the Ground do so at their own risk. The Company cannot guarantee entry to the Ground if the spectator arrives at the Ground more than 30 minutes after the advertised kick off time.
- (4) Any person who enters the ground is liable to be searched by a Safety Steward or representative of the Company and the Company reserves the right to refuse admission to, or to eject any person from the grounds. Any person who refuses to be searched or who fails to comply with instructions from a Safety Steward or other person acting for the Company will be refused entry or ejected.
- (5) The Company reserves the right for its Safety Steward or representative of the Company to remove any person from the Ground who does not comply with the Ground Regulations, or whose presence in the Ground is, or could reasonably be construed as, constituting a source of danger, nuisance or annoyance to spectators or other persons attending the Ground.
- (6) In connection with the Company's Child Safeguarding Policy children aged 14 and under will not be permitted into the Ground unless accompanied by a responsible adult 18 years and older.
- (7) Babies in arms will be admitted access free of charge at parents consent. All children over the age of 2 years of age (24 months) will require an event ticket to gain entry into the Ground. No pushchairs or prams are allowed into the Ground
- (8) With the exception of persons authorised by the Company and holding official accreditation the taking of photographs, video photography or any other recordings for commercial use within the Ground is prohibited. Mobile phones and other

communications devices are permitted within the Ground provided that they are used for personal and private use only.

- (9) Only persons specifically authorised in writing by the Company are permitted to distribute without charge or offer for sale in the Ground, programmes, newspapers, periodicals or any other articles, or carry out charity collections.
- (10) With the exception of guide or assistance dogs, animals are not permitted in the Ground.
- (11) The following actions are prohibited and will constitute an offence under these Regulations. any person committing such an offence will be ejected from the Ground:
 - The throwing of any object onto the field of play or into any area around the Ground in which spectators are present.
 - Behaviour likely to cause confusion, nuisance or offence of any kind, including racial, homophobic, discriminatory, foul or abusive language.
 - Unnecessary noise such as that from the use of mobile devices of any type or instruments.
 - The riding of bikes, the use of scooters, skateboards, electric skateboards or similar devices around the Ground during an event. The Company reserves the right to confiscate such items until the event has finished.
 - Unauthorised persons to enter upon the field of play (except in the event of emergency). Access or attempting to gain access to non-public areas of the Ground or areas of the Ground not authorised by the event ticket.
 - No person may obstruct or remain in any gangway, entrance, exit or staircase at any time. Any person who remains in a designated 'no standing area' or refuses to move after reasonable requests from any area by a Safety Steward or other person acting for the Company.
- (12) Subject to the number of spectators in a seated or standing area the use of umbrellas and selfie sticks or similar objects may be restricted or prohibited.
- (13) Fireworks, smoke canisters, flares, laser devices, bottles, glasses, cans, flagpoles greater than 1m in length or other similar items, including anything which could or might be used as a weapon, are not permitted within the Ground.
- (14) Other than in exceptional circumstances permitted by the Company no person may bring into the Ground any food or beverages. Any person in possession of such items will be asked to dispose of the article and may be refused entry or ejected.

- (15) Any person within the Ground or attempting to gain access to the Ground who is, or appears to be under the influence of alcohol or drugs will be refused entry or ejected.
- (16) When the Ground is used for events smoking is not permitted in the Stands or terrace areas. All open areas are designated 'clean air zones' under the Company's Smoking Policy and smoking in these areas will be in breach of the Ground Regulations. Permitted smoking areas are provided and the locations shown on signage. Smoking includes the use of E-cigarettes.
- (17) All vehicles shall be parked in accordance with instructions by Safety Stewards or representatives of the Company. The Company will not be liable for any loss or damage to any vehicle or its contents in the car park.
- (18) Any vehicle that enters the Ground is liable to be searched by a Safety Steward, or representative of the Company and the Company reserves the right to refuse admission.
- (19) Closed Circuit Television (CCTV) is used during an event for the purpose of crowd safety management. Where there are instances of public disorder the recordings will be available to South Wales Police.
- (20) Ticket holders give their express consent to the use of their actual or simulated likeness in connection with production, exhibition, advertising or exploitation of any film, video and/or audio recording of this event, and/ or element thereof in/any media throughout the world.
- (21) The Company reserves the right to amend these Regulations in special circumstances at any time and where possible will display such changes on its website.
